

The total closure of the Deux-Montagnes line anticipated

The "rail shuttle" - which has become the only one to run between Deux-Montagnes station and Bois-Franc station since the start of 2020 - will cease its activities on December 31 rather than in mid-2021, as planned. All stations on the line will be closed at the same time.

Trains will completely stop running on the Deux-Montagnes commuter train line sooner than expected, while the metropolitan transport authorities are banking on buses to mitigate the effects of the Metropolitan Electric Network (REM) project.

The "rail shuttle" - which has become the only one to run between Deux-Montagnes station and Bois-Franc station since the start of 2020 - will cease its activities on December 31 rather than in mid-2021, as expected. All stations on the line will be closed at the same time.

"It was decided to bring it forward [the clos-



ure] for the simple reason that we were able to offer a service that was better than the rail shuttle," said Sarah Bensadoun, spokesperson for Mobilité Montréal. "Right now, people are taking the train, stopping at the Bois-Franc station which is the terminus. Then, they take a shuttle bus that takes them to the Côte-Vertu metro and

then they take the metro to go to town," she explained. "With the new services, we are eliminating connections and improving journey times.

"The new solutions announced Thursday include an increase in frequency of shuttles that already exist, and new lines shuttle. These will be able to take advantage of shoulders designed to allow their circulation on several highway sections of Greater Montreal. They would save "15 to 45 minutes of travel time", depending on the route, assured Ms. Bensadoun.

COVID-19 has had a devastating impact on ridership throughout the public transit network and the services put in place to address the problems created by the REM worksite are no exception. The rail shuttle between Deux-Montagnes station and Bois-Franc station thus suffered a 90% drop in ridership.

Residents of Deux-Montagnes should be able to use the REM to get to downtown Montreal in 2023

Mayor Eric Westram and Rosemère's town councillors invite residents to attend the upcoming Héma-Québec blood drive on September 24 and 25. The blood donor clinic, which is by appointment only, will be open between 1 p.m. and 7:30 p.m. at the Memorial Community Centre (202 Grande-Côte Road).

"Even during a pandemic, there is an ongoing need for blood," Mayor Westram said. "That's why I want to reassure residents about the protective measures taken by Héma-Québec. They have proactively implemented the recommendations from public health officials and Health Canada in order to provide a safe environment for everyone.

Join me in giving blood on September 24 and 25, and let's help save thousands of lives. Together, we can meet our goal of 170 donors."

Because the blood drive is by appointment only, residents must contact Héma-Québec in advance by phone at 1-800-343-7264 or by email at igive@hema-quebec.qc.ca.

Access to all donation sites is controlled, with a temperature check for donors and volunteers before they can enter.

Donor beds are disinfected after every use, as are the touchscreens used to fill out the donor questionnaire.

The set-up of the blood drive has been reconfigured to comply with distancing requirements. Acrylic dividers have been added at all blood donation locations.

Surgical masks, provided by Héma-Québec, are

mandatory for all donors for the length of their visit as well as for staff and volunteers whose duties require them to be closer than 2 metres (6 feet) to others.

Speak softly and start believing.


Nothing personal but the language or languages you speak may influence whether you become infected with the Covid virus. Different languages spew more moisture than others. Do you speak softly, or loudly? Do you project when you speak, like singers, teachers, and broadcasters?A study in the journal Aerosol Science and Technology, says this all has an effect on how the virus will impact you. For example when we speak English, we aspirate a lot. We produce voiceless but plosive consonants like p, t, and k. We pronounce those letters within a word with exhaling breath. A researcher named Sakae Inouye from the University of Tokyo observed that like English, the Chinese language actually has even more aspirated letters. Inouye concluded that in Chinese, "the consonants p, t, k, q, ch, and c, when placed in front of vowels, are pronounced with a strong breath". In fact when a Chinese, English and Japanese speaker were compared, the tissue in front of their mouths fluttered in English and Chinese but not in Japanese. That could be the reason Japan has only one third the number of Covid cases of Canada, yet it has three times Canada's population. And if you speak French and most of us do, you will agree that at least anecdotal evidence suggests the expressive French, Italian, and Greek speakers have plenty of potential viral particles to pass onto others! Now it can't all be attributed to language because the Japanese have a mask wearing culture, are disciplined in social distancing, and respect their government's suggestions of avoiding crowds. We are still learning about this virus, but it's worthy of note that different speech sounds produce either more or less moisture according to the study in the medical journal LANCET. And loud speakers clearly emit more aerosolized particles than soft spoken speakers, in some cases ten times as many! So whichever way you chose, try to reduce your air flow, and keep your moisture to yourself.

No matter what language we speak we are all human beings and as humans, we tend to lie, a lot. A recent study found fully one third of the population lies about whether they have symptoms or have in fact been infected. Psychology researchers at St Catharines Ontario's Brock University found "34% of those testing positive denied having symptoms". Women more than men were more honest, older but not younger adults told the truth.

But what bothers me the most, is the recent on line Leger survey clearly showing pandemic fatigue has set in, and fully half of Canadians think our politicians are holding back information. Younger Canadians find politicians and health officials exaggerate the severity of this deadly virus. Why? Because we've been lied to, too often. Italians were told the virus was created in a Chinese lab. The Chinese said the virus originated with the US military. Donald Trump said the anti malaria drug hydroxychloroquine was the cure. Ottawa Public Health said recovered patients of the virus would not be reinfected for at least two years. Granting 14 day exemptions to Uline U.S. billionaire Liz Uihlein and her gang's private jet fly in for their 36 hour visit to Milton Ontario. That severely undermines public confidence. We were told masks were not effective. Yes they are. Health Minister Patty Hajdu admitted "We knew very early about COVID-19, the risk that it posed to human health". This was in December 2019! Hajdu, Justin Trudeau, Doug Ford, and no doubt other politicians that we don't know about have not followed their own rules. Teachers complain about class sizes but it was an infected teacher (no mask) who forced the closure of a Pembroke high school. And I am not alone wondering why 50 people can gather in a strip club but only 10 are allowed at a house party. And so one can perhaps understand why many no longer believe what they hear and have dropped their guard. And what about a vaccine. Can it be trusted now? All this despite a troubled Premier Legault saying "The situation is critical...please think about others", promising more powerful screen ads but he hasn't changed the rules, yet. Ontario's Doug Ford has, and is fed up, instituting a system of provincially enforced measures that cary heavy fines. I read this recent powerful commentary from an outraged Canadian, "Not realizing, or not caring about our overworked medical staff, selfish, spoiled, disrespectful citizens are going to kill us". Most believe, some don't. The sad reality is one infected can send 30 others to hospital, hopefully to recover, thanks to our dead tired doctors

and nurses. That's what I'm thinking.

very month, Statistics Canada reminds us that life is getting more expensive. But for food, the situation has been unique over the last few decades.

Based on numbers released recently, the price of a typical grocery basket has increased by about 240 per cent since 2000.

Some will think such a percentage is expected, given the effects of inflation. However, the overall cost for other products and services in the economy didn't increase as much as food did – far from it.

When we compare the consumer price index with the food price index over the last 20 years, we see a rather marked divide.

Except for in Iqaluit, all provinces and territories have seen their consumer price indices outstripped by the food price index. In most cases, the food price index has gained at least 10 points more in 20 years.

The differences are larger in Eastern Canada. In Quebec, the difference between the two is 23.1 points and in Nova Scotia, 21.3 points. The place where the food price index exceeded the general price index the most is in New Brunswick, at 25.8 points.

So over the past 20 years, Canadian households – especially in Eastern Canada – have had to spend more of their budgets on food. Especially in the last decade, the gap between the two indices has widened. For the eastern provinces, the reasons vary between the lack of regionally-based food processing and the higher logistical costs of serving some remote markets.

Some may say a sustained rise in food prices may be harmful to the poorest citizens. Well, yes and no.

North America has been the realm of discounted food for some time. We're just coming out of an era in which we've been bent on buying the cheapest food products. For a generation, food industrialization has led us to consume both good and questionable food and we accepted our fate without thinking much about it.

But things are different now. As affordability remains a priority for the agri-food sector, quality, the provenance of food, and the ecological footprint that our choices represent bring their share of complexities and additional costs.

The demanding consumers we have become have plenty of choice, year round. With more innovation, quality is also much better – but there's certainly a price to pay for that.

As a result, the industry has been catching up to our expectations by managing higher costs and passing some of the increases onto us. It will only get worse with COVID-19. It's simple economics.

But the fact remains that some people are struggling to make ends meet. Poverty is invisible but it's there, it surrounds us and will become more of a challenge over the next several months. It's high time to evaluate the possibility of a guaranteed minimum income, for greater financial equity for all.

Despite higher food inflation, there's still some good news for bargain hunters. For several years, we've focused on discussing the more expensive food products. It's just human nature. But did you know that there are a few products priced almost the same as they were 20 years ago?

According to Statistics Canada, flour has increased by 38 per cent since 2000. That's not much. Even better, peanut butter is about five per cent more expensive than in 2000. Of course, prices will vary depending on the region, the type of store and the time of year. But peanut butter has been relatively cheap for 20 years.

And sugar is dirt cheap in Canada. According to Statistics Canada, white sugar is almost the same price as it was in 2000, at \$2.40 per two kg. Although there are only three sugar producers in Canada that control the market – Redpath, Lantic and Rogers in the West – the price of sugar has barely changed in the last two decades.

The sugar industry operates mostly behind the scenes and everything is negotiated privately. Canadian prices are based on world sugar prices, which are significantly lower than prices supported by tariffs in the United States and Europe.

Canada's low import tariffs also mean that global competition for refined sugar keeps prices low here compared to the United States. Sugar prices in Canada are on average about 35 per cent lower than U.S. sugar prices. So food prices are going up, but at least sugar and peanut butter remain a bargain.

Are the nasal pcr tests for Sars-2-cov too "sensitive"?

Dr. Christos Karatzios clarifies

A lot of commotion in the news lately concerning tests. The good news is that newer and faster tests are being developed with a saliva gargle test on the verge of approval in BC.

At CNN though, there was a headline in the ticker tape that turned heads and spread like a virus (pardon the pun) in all sorts of conspiracy web pages. "Health experts warn Covid-19 tests aren't just slow, they're too sensitive". NSN reached out to Dr. Christos Karatzios Assistant Professor of Paediatrics at the Montréal Children's Hospital for a muchneeded clarification.

The doctor started by saying that people didn't understand what they were reading and of course they told him that positive tests are "false positives".

His answers are all here:

Yes, the tests are sensitive. They HAVE to be. They pick up genetic RNA material of SARS-2-CoV in your nose.

No, the tests do not pick up false positive results. The nasal PCR test for SARS-2-CoV ONLY DETECTS SARS-2-CoV and nothing else. So, it doesn't pick up "other coronaviruses".

The false positive rate is extremely low and mostly has to do with lab error (i.e. contamination with a positive sample in the lab). This is very rare.

The false negative rate is much higher due to various factors (i.e. sampling error - not getting the swab deep enough in the nasal passage, or sample timing - too early in the disease or too late).

The test is a "YES" or "NO" test for the presence of the virus. It tells you nothing about live (growable and infectious virus), or dead remnant pieces of the RNA (therefore not infectious virus).

Someone can remain positive for weeks as many of my friends reading this have. Some have stayed positive for 6 weeks. It does NOT mean they are contagious all these weeks.

Immune suppressed people and people with severe COVID-19 (in ICU on a ventilator etc), may be contagious for 3-4 weeks.

For the rest of the healthy population (i.e. children in school) who got COVID-19, live infectious virus stops shedding after about 10 days. Your test can still pick up genetic pieces after this but the virus is dead.

A quick hint: do you have fever and a bad cough and diarrhea? You're contagious until all gone. You were contagious 1-2 days before it all started.

A PCR is a test that checks for the genetic material and, if present, enzymes in the test start making copies of the genetic material until we are able to detect it. The checking happens in cycles. The less cycling needed to detect, the more genetic material that exists in that swab and so the Ct (cycle threshold) is LOW. The less genetic material that exists in the swab, the higher is the Ct.

This is NOT a viral load. It does not give you a number of copies of the virus per mL of snot or per nasal surface cells in your nose. This is the major mistake many papers and scientists are making.

A viral load has a curve - so therefore it rises - and it falls -. Scientists can only presume that with the current PCR test the Ct rises and falls too. But a viral load curve needs a denominator to be constant and that is the sample. In HIV we know the viral load of a patient because we

sample a constant blood volume. For a respiratory virus like SARS-2-CoV, it depends on the sample and this isn't constant as many of you who have had the test done know - you thrash about because it's uncomfortable and there may be less cells in the nasal swab. Or the testing person samples the front of the nose where the virus doesn't live well when compared to the back of the nose. There is no constant denominator unlike a blood test - and we don't have those developed for this pandemic.

Unlike flu (300 viral particles in droplets but 3 if airborne), Shigella causing shigellosis and dysentery (1-10 bacteria), and Salmonella causing typhoid fever or other salmonellosis diarrheal illnesses (100-200 bacteria) we do NOT know the infective dose of the SARS-2-CoV.

So, even if we knew the viral load of the test we would not know what it meant. Does it take 1, 10, 10,000 viral particles to cause COVID-19? What about black people who have higher numbers of ACE receptors for the virus, or kids and mild asthmatics who have less? How many viruses are needed to cause disease in them? We just don't know and we will not know for a while. Remember we are learning as we live. We are building the boat as it is sailing during this pandemic.

Also, what if the viral load is low...can a child return to school let's say as was suggested by CNN? How do you know if the viral load is on the upswing (early in the disease and the patient is asymptomatic and will have a big viral load in a few hours when he/she becomes presymptomatic) or late in the disease as it has passed?

In conclusion, yes, the tests are sensitive but they are specific for this virus only. If positive we don't know where you are on the disease timeline unless you have symptoms. Isolation

and contact tracing are the only way to control this disease apart from wearing masks, washing hands, and keeping distances. Unfortunately, we can't predict who can go to school or who can't. If an outbreak happens based on positive tests, a school may need to fully close. Unfortunately, that's the limits of our technology. Maybe in a few months we will know more.

TWO MOUNTAINS TO CLIMB CANADA'S TWIN DEFICITS AND HOW TO SCALE THEM by David Dodge



Two Mountains To Climb: Canada's Twin Deficits

and How to Scale Them

Canada must come to grips not just with a massive fiscal shortfall but also consecutive deficits in our current account, a broad measure of our trading and investment relationship with the rest of the world. A government plan must be growth oriented if we are to get the twin deficits under control without resorting to the drastic measures of 25 years ago.

INTRODUCTION

The 2020 COVID-19 crisis has produced a unique economic emergency layered on top of a decade-long build-up of pre-existing weaknesses. One cannot be addressed in isolation from the other.

The 21st century began well for Canada. Our fiscal turnaround had proven durable as our debt-to-GDP ratio moved steadily downward. We were running a current account surplus with the world on the backs of strong demand and good prices for our exports and net inflows of foreign direct investment. We were building our net worth as a nation and setting the stage for future growth through the creation of new economic capacity. As a result, jobs and income were on the rise, along with opportunity.

But the situation began deteriorating in the second decade of the new century. The current account, a broad measure of our trading and investing relationship with other nations, turned negative and remains there. Non-energy exports never recovered after the Great Financial Recession and the tide turned against investment in Canada following the 2015 oil price collapse. In the long run, the real income of Canadians and the public programs they cherish depend on the value of the goods and services (GDP) Canadian workers and businesses produce. We maximize their impact by exporting those in which we are most cost efficient and importing those where we are less

Long before COVID-19, however, the signals were straightforward and stark: Canada's industries were losing ground in global competitiveness and attractiveness to foreign investors. Even Canadian businesses and individuals were finding more appealing places to invest. We were no longer building our future at home, but rather collecting rents in the present on investments from the past, like coupon clippers living off past prosperity.

Today, policymakers are being called upon to address these pre-COVID economic and policy weaknesses alongside brand new pressures introduced by the crisis—the explosion in public debt, heightened demands for social security and health care and, leaving aside long-term climate pressures for the moment, the further erosion of the price for our largest export category by far, crude oil and bitumen.

It is more incumbent than ever for governments to know where they are headed overall, and to communicate effectively with citizens, markets, global trading partners and investors about how we intend to get there. If Canada is to fully recover from the COVID crisis, we need to articulate and promote a medium and long-term plan to restore ourselves as a favoured destination for investment and to use that investment to enable forward-looking industries and entrepreneurs to make and sell what the rest of the world wants to buy from us. This is the way to enhance the standard of living for Canadians.

The messages of this paper are very simple:

- You can't eat what you don't produce, and the value of what we are producing as a country is not covering what we are consuming. We can continue along that way for a while, but it is not a sustainable proposition.




Figure 1: Net Saving as % of National Disposable Income | 1981Q1 to 2019Q4 Source: Statistics Canada, table 36-10-0111-01.

- You need to invest today to produce more and better in the future. Over much of the past decade, we have been investing less in our future while consuming more in our present, as evidenced by our lower net national savings rate (Figure 1). The COVID crisis exacerbates those trends.
- You want to produce where your value is greatest. We need to add greater value to what we produce and, to the extent we are moving away from our biggest export, oil, we need to find competitive replacements that are attractive to buyers abroad and secure access to those markets.
- You need greater productivity increases to compensate for an aging population. As our population ages, the growth of our labour force slows—and so doesn't provide our historic natural growth of output. In order to preserve our living standards and quality of life, we need to maintain high immigration levels and ensure faster productivity gains.

Ultimately, this paper is optimistic in seeing in the COVID crisis the shock we have needed to muster the attention and will to address our weakening economic base. Over the past decade, the Canadian economy has been like the David Allison Dodge is a Canadian economist who served a seven-year term as Governor of the Bank of Canada from February 1, 2001 to January 31, 2008.

proverbial frog in the pot of water, never really feeling the gradually rising heat and therefore failing to react proportionately. The COVID crisis represents a sudden rise in temperature.

It is not too late for Canadian policymakers to get this right and bend the future more definitively in the favour of Canada and Canadians. This paper sets out some thoughts on how this can be done.

PART I: THE CURRENT ACCOUNT CHALLENGE

Most attention to the economic effects of the COVID-19 crisis has been devoted, not inappropriately, to Canada's burgeoning fiscal deficits and the labour market insecurity of Canadians. While one may quibble with this measure or that, a robust government response to an unprecedented crisis was absolutely necessary—and so we will have to determine how to distribute the burdens of this debt over time and among different segments of the population.

There is a second deficit that also merits

serious public attention. Canada's current account provides a reliable reflection of the medium-term strengths and weaknesses in the economy. The current account represents the sum of Canada's economic interactions with the rest of the world—imports and exports of goods and services, payments to foreign holders of the country's investments against payments received from investments abroad and transfers such as foreign aid or remittances. The current account can be in deficit for a time without problem. During an economic expansion, for instance, Canadian purchases of capital and consumer goods from abroad may rise.

But a chronic current account deficit that never corrects, particularly in times of global economic uncertainty, eats away at the confidence of foreign lenders and investors, sometimes resulting in sudden plunges in the value of national currencies and the rise, in response, of domestic interest rates—something Canada experienced in the mid-1990s and can ill afford

The partners of Mobilité Montréal presented the second phase of the mitigation measures related to the work of the Réseau express métropolitain (REM).

The implementation of this new service offer is made possible thanks to the faster completion of the development of the bus lanes on several strategic motorway axes.

Over the past few months, Mobilité Montréal's partners have stepped up efforts to develop mitigation measures to facilitate access to downtown Montréal. The objective was to implement efficient and competitive solutions in terms of travel time, in addition to offering several route options to public transport users.

A new, improved service offer will be in effect from November 2, resulting in a transitional period during which the train and the new bus shuttles will be in operation simultaneously. Thus, users of the Deux-Montagnes line will have the opportunity to test different routes to determine their preferences before stopping the rail shuttle scheduled for 31 December 2020.

The new measures include:

development of "bus lanes on highways 640, 13, 15 and $\hat{25}$, as well as the use of the new reserved lane of highway 20 in the Turcot interchange;

shuttle 404, between the Deux-Montagnes station and the city center, which now becomes the main measure for access to the latter during rush hour. Initially planned outside peak hours, this shuttle was extended as soon as it was set up and will remain available at all times, including evenings and weekends:

two new bus shuttles during peak hours:

line 499 from the Deux-Montagnes station to the Côte-Vertu metro (for users having to go to the Saint-Laurent borough);

line 498 from the Saint-Eustache terminus in downtown Montreal, with a stop at Sainte-Dorothée station:

the optimization of the 968 - Trainbus Roxboro / Côte-Vertu shuttle service, with only three stops, namely the Roxboro-Pierrefonds and Sunnybrooke stations as well as the Côte-Vertu metro:

a rate change for zone 3 users so that they can access the TRAMREM fare at the rate of \$88.50. This ticket will allow them to travel on board all modes of transport in zones 1, 2 and 3, including the metro from Montmorency station in Laval.

These new features are in addition to the service currently deployed in the North Shore and on the Island of Montreal.

For users of the Mascouche line, the service already in effect continues.

"At my request, a considerable effort has been made by all of Mobilité Montréal's partners to offer the most direct service possible to the city center and the metro for users affected by the shuttle stop. railway. The development of lanes on major roads will now allow buses to avoid congestion. This will have a positive impact on the travel time of thousands of users. By now prioritizing bus services, we are responding more adequately to the needs expressed by users of the Deux-Montagnes line. Our government is listening, which makes it possible to present today a



plan that will optimize travel time and which, by the same token, will make the use of solo cars less competitive than the use of public transit. said Chantal Rouleau, Minister responsible for Transport and Minister responsible for the Metropolis and the Montreal region

The mitigation strategy of the partners in public transport has been designed in an evolutionary way in order to allow the integration of the new resources available to improve travel options as the REM site evolves. I would like to salute the concerted work of Exo, the Réseau de transport de Longueuil (RTL), the Société de transport de Laval (STL) and the Société de transport de Montréal (STM), as well as the

government's involvement. of Quebec, CDPQ Infra and Mobilité Montreal. We are all committed to providing the best possible service to affected users. » added Benoit Gendron, Director General of the Autorité régionale de transport métropolitain

The transitory public transport network represents an investment of \$ 192 million by the government of Quebec and CDPQ Infra.

Work to develop the park-and-ride lot on avenue des Bois as well as the lanes of avenue des Bois, highway 440, eastbound, and boulevard Chomedey, in Laval, will continue until spring 2021 and will facilitate transit for Laval users.

An approach adapted to the different regions to limit transmission of the virus

It is now more important than ever that we follow health measures to limit the spread of the virus. It is essential that each of us remains vigilant and adopts good habits. Since the virus is not spreading everywhere at the same rate, a new tool has been implemented to show how the situation is evolving in each Quebec region. This four-level alert system will make it easier for you to keep track of the government's interventions.

We must contain the spread of the virus throughout Quebec. This is how we can retain some level of normalcy over the next few months. Each region can make a big difference in limiting the spread of the virus. Let's continue to protect each other.

Progressive regional alert and intervention system

The Progessive regional alert and intervention system specifies which additional measures each health region must take to slow the transmission of the virus. These depend on the alert level reached and are intended to limit the health, social and economic impacts of COVID-19, protect those who are most at risk and avoid overburdening the healthcare system.

The alert levels are established based on the recommendations of public health authorities who regularly review the situation, taking into account the epidemiological situation, transmission control and the capacity of the healthcare system.

Don't forget that everyone must adopt behaviours that limit transmission of the virus. We do it to ensure that our children can keep going to school, to protect our seniors, to ensure the safety of our healthcare workers and to revive our economy. **Follow the basic measures at all times:**











- Keep your distance
- Wear a face covering
- Cough into your elbow
- Wash your hands
- Adapt your greetings



FOUR ALERT AND INTERVENTION LEVELS

Vigilance

Level 1 requires constant attention amid the COVID-19 pandemic. It corresponds to a low level of transmission in the community. It requires that **the basic measures established be followed** in all settings (physical distancing, respiratory etiquette, hand washing, etc.). Special measures may also apply to certain activities or settings.

Early Warning

This level is imposed when the level of transmission starts to increase. The basic measures are reinforced and further actions are taken to promote and encourage compliance. For example, there might be more inspections and crowd control in some settings to facilitate physical distancing.

Alert

Level 3 introduces additional measures that target specific areas of activity and settings where the risk of transmission is deemed higher. These areas are subject to selective restrictions, prohibitions and closures.

Maximum Alert

Level 4 selectively applies more restrictive measures up to and including ceasing non-essential activities for which the risk cannot be sufficiently controlled, while avoiding the generalized confinement that was experienced during the first wave of the pandemic as much as possible.

The city of Rosemère has put various grant programs in place to provide financial support for residents looking to embrace environmentally friendly and community-minded solutions.

Sustainable feminine hygiene products

Effective July 13, 2020

The Town of Rosemère offers residents an opportunity to obtain financial assistance of up to \$40 per 3-year period for the purchase of sustainable feminine hygiene products or fabrics to make reusable (washable) sanitary napkins.

Buy menstrual cups, pantiliners and sanitary

napkins that are washable, reusable and designed for use by women and apply for financial assistance from the Town.

Documents to be attached to one's application are: a copy of the original bill(s) of sale dated less than 3 months ago and indicating the name of the commercial establishment that made the sale as well as its GST and QST numbers, Proof of residence and a duly completed form

To apply, residents must download the Sustainable feminine hygiene products grant program application and then send the form and required documents by e-mail to loisirs@ ville.rosemere.qc.ca or in person to Community Services located at 325 Grande-Côte Road.

Reusable diapers

The Town of Rosemère offers families the possibility of applying for a rebate of up to \$150 per eligible child against the purchase of a set of washable baby diapers.

Diaper facts and figures:

The average baby goes through 2 400 diapers

A set of cloth diapers costs between \$700 and \$1 000, laundering included. For disposable diapers, the total cost runs anywhere from \$2 000 to \$2 500.

In Quebec alone, some 600 million diapers are thrown away every year.

A disposable diaper takes 300 to 500 years to decompose in a landfill site.

One birth, one book

Under this program, the Town of Rosemère offers a gift package to welcome newborns into the community.

To apply for both programs above, residents must download the Family Support Grant Program application, fill it out and sign it and then drop it off to the Community Services Department at 325 Grande-Côte Road (450-621-3500, ext.7380). Residents must provide Receipt(s), Proof of residency and the Child's proof of birth

One birth, one tree

The Town of Rosemère offers new parents the possibility of applying for a \$150 rebate against the purchase of a tree or other type of vegetation (such as a bush or shrub) to plant on their property to commemorate the birth of their child.

To apply residents must download the Family Support Grant Program application, fill it out and sign it and then drop it off to the Public Works Department at 190 Charbonneau Street (450-621-3500, ext. 3300). Residents must provide Receipt(s), Proof of residency and the Child's proof of birth

Low-flow fixtures

The Town of Rosemère offers a rebate program to encourage homeowners to replace their existing plumbing fixtures with low-flow alternatives.

Eligible fixtures and maximum rebate amounts are as follows: low-flow (\$60) and high-efficiency (\$75) toilets, and WaterSense-labelled shower heads (\$10) and faucet aerators (\$25).

To apply residents must download the Low-Flow Fixture Grant Program application.

Fill it out and sign it and drop it off to the Public Works Department at 190 Charbonneau Street (450 621-3500 ext. 3300). Original proof of purchase for eligible low-flow fixtures, photograph (dated and initialed by the homeowner) showing the original fixtures and where they were installed and photograph (dated and initialed by the homeowner) showing the low-flow fixtures after installation are required.

Home support services for seniors

Seniors may request an application form to fill out and submit in order to qualify for a refund (by cheque) in the amount of \$100 for the home support services they are provided. Please note that refund applications are processed between September 15 and December 15 of the current

Homeowners must be 65 years of age or older on July1 of the tax year. Their taxes must have been paid in full. All requests must be submitted by November 30 of the current year (the year for which the application form is completed). The refund application is valid for one year only. You must fill out and submit the form each year. To apply, the form has to be completed and sent to Rosemère Town Hall, 100 Charbonneau Street, Rosemère, Quebec J7A 3W1

Blainville tightens the leash

New regulations for dog owners

In 2018, the government of Quebec adopted Bill 128 aimed at promoting the protection of people by setting up a framework for dogs and in December 2019, it ratified the implementing regulations for this law which only potentially dangerous dogs, but also all dogs in Quebec to ensure the protection of the public.

"The municipal council, in order to strengthen animal control on its territory as well as the safety of people, adopted By-law 1620. This substantially modifies the elements relating to pets while integrating the elements of Law 128 and its implementing regulations on dangerous dogs. There were 45 incidents involving dogs in Blainville between 2010 and 2018. As a Quebec municipality No. 1 for its quality of life, even if the old regulations contained tough measures, Blainville must ensure the safety of its citizens," declared Mayor Richard Perreault.

The City also wishes to ensure ethical and safe animal control and limit the proliferation of stray animals on the territory.

By-law 1620

The number of animals per property is limited to four, including a maximum of three dogs or three cats. A person who was already keeping more animals than authorized before the adoption of the by-law must obtain a special permit

from the City. In a survey conducted by the firm Aramis in March 2019 to which 854 citizens of Blainville responded, 74% support this measure.

In a public place, a dog must at all times be under the control of a person capable of controlling it and be held by a leash of a maximum length of 1.85 meters.

It is now compulsory, under provincial and municipal regulations, for all dogs weighing 20 kg and over, to wear a halter (head harness) or a chest harness when circulating in public places (streets, parks, green spaces, etc.).

The control of dogs deemed potentially dangerous or dangerous following incidents is reinforced according to the obligations contained in the implementing regulation of Law 128 (85% support in the 2019 survey).

Under provincial regulations, registration and wearing of the medal for all dogs in the territory is compulsory. Cats must also be registered and wear the tag.

Finally, the regulation makes the sterilization of cats aged six months and over, mandatory in order to avoid the proliferation of animals (65% support in the 2019 survey).

Registration and medal compulsory for dogs and cats

"As mentioned, Law 128 and its implementing regulations make registration and wearing of the medal compulsory for dogs. Cats are also subject to this obligation in the municipal bylaw,"



mentioned the chairman of the public security commission, Serge Paquette.

The registration of dogs and cats is valid for the life of the animal. To register a dog or cat, there are two options: complete an online form and receive the medal by mail (\$ 25 + \$ 3 postage) or go to an authorized partner to complete the form, register an animal and receive the medal (\$ 25). The sums collected for registration are used only to pay the operating costs by the SPCA and to produce the medals.

Halter and chest harness

According to provincial regulations, Municipal By-law 1620 makes it compulsory to wear a halter or chest harness for dogs over 20 kilograms.

"The halter is a harness that is placed on the head of an animal in order to control it effectively. The halter is not a muzzle and does not prevent the dog from breathing freely. This device increases the effectiveness of the leash and gives the keeper better control. The halter also has the effect of calming the dog, "added the vice-president of the public security commission, Michèle Murray.

As for the chest harness, it has the particularity of attaching to the front at chest level and not on the back as with conventional harnesses. This type of harness is designed to gently discourage dogs from pulling since it is used to restrain sudden movements without harming them.

The Order of Veterinary Doctors of Quebec is in favor of this equipment, which increases the protection of citizens while respecting the well-being of the animal.

Regulation 1620 also contains several articles relating to the welfare and protection of animals and the City of Blainville site includes more information on that.

Fast forward to the 1980s as Wonder Woman's next big screen adventure finds her facing two all-new foes: Max Lord and The Cheetah.



Let's talk about this black gem first. Being of Greek descent, olives were always a staple in the house. Never canned, always bought fresh from the deli counter from our favorite Mediterranean supermarket. There are hundreds of varieties, and depending what meal you had, there is always a particular olive that would accompany a dish. For instance, a Kalamata olive would be great in salads, plump and just a little tart. Most olives are great with seafood or simply as a snack!

In this recipe, the Throuba olive (if you can't find this type, the closest is Moroccan) is added to the bread. It's so soft yet very fleshy, and the saltiness gives the bread so much flavor. Indigenous to the Island of Thassos, northern Greece, it is the only place it can be found. Apparently, it's the only olive that can be eaten straight off from the tree! Olives are not fresh fruit, and need to be cured for months to remove their bitterness before eaten . The Throuba olive, meanwhile, is barely treated at all, thanks to a naturally-occurring (and entirely safe) fungus that grows on the tree.

The olives are left to dry naturally on the tree before being handpicked and processed in water and soaking them in unrefined sea salt. Any liquid that comes off is drained, avoiding the absorption of excess salt

The Throuba olive is one of my favorite olives and are particularly good when enjoyed with a light, medium-bodied red wine. Otherwise, use them in the usual olive-friendly dishes that are not too salty. You can pair it with less salty cheeses, use as a pizza topping or add them to a bread recipe. This bread recipe is so easy, and the sweetness from the juice makes for a welcoming bite from the salted olives! Enjoy!

Ingredients

- 1 kg of flour, could be bread flour or all purpose
- 2 sachets of dry yeast
- 1 teaspoon fresh, chopped mint (optional) or any other herb
- 1 cup pitted olives (black olives, preferable Moroccan or Throuba)
- 20 grams of salt
- 650 ml of any fruit juice

Instructions

 Put the flour, the yeast, the herbs and olives into the bowl of the food processor (or kitchen aid) and mix with the hook. Add the salt to the juice, mix with a spoon and slowly add to the bowl. Knead until the dough comes off the sides. Put a little flour in another bowl and put the dough in, cover and leave for 40 minutes in a warm place, until it doubles in volume.

Knead into loaves, leave the dough in a pan with flour to rise, for about 40 minutes. Score the bread with a knife and bake in a preheated oven at 375 degrees for about 50 minutes, or until the crust is golden brown.

Note: the color of the bread will be darker because of the fruit juice.




